The Michigan Public Service Commission (Commission) will hold a public hearing to consider American Transmission Company LLC and ATC Management Inc.'s, (collectively, ATC) October 14, 2013 application for a certificate of public convenience and necessity to construct an approximately 60 mile 138 kV single circuit overhead electric transmission line between ATC's existing Holmes Substation in Holmes Township, Menominee County, Michigan and the Old Mead Road Substation in Escanaba Township, Delta County, Michigan. ATC represents that the new transmission line is necessary to improve transmission system reliability in the region.
